

Standard Operating Guidelines (SOG)

DUTY POSITION DESCRIPTION

SCOPE

This guideline shall apply to all members of the Stoney Point Fire Department and shall be adhered to by all members.

PURPOSE

To establish the performance requirements for each operational position within Stoney Point Fire Department.

DEFINITIONS

Captain – Company Officer, senior shift leader, responsible for safety, training, and leadership

Chief Officer – Senior Fire Officer rank, Division, Assistant, Deputy and Fire Chief, responsible for safety, training, leadership, planning and operations

Driver/Operator – firefighter trained to operate specific apparatus

Engineer – firefighter trained, certified and qualified to operate all apparatus

Firefighter – trained personnel assigned fire suppression duties within a crew or Company

Guideline - a general rule, principle, outline of a policy

Lieutenant – Company Officer, shift leader, responsible for safety, training, and leadership **Member** – any career, volunteer, staff, and auxiliary personnel affiliated with the department **Shall** - indicates a mandatory requirement

GUIDELINES

Membership with the Stoney Point Fire Department is an opportunity for public service. This service confers no special rights or privileges, but it does impose responsibilities and duties upon the member. Honesty, integrity, reliability, discipline, fairness, diligence, and competence are all required of Stoney Point Fire Department members. This guideline details the tasks that may be assigned to members in each duty position, and the requisite education, training, knowledge, skills, and abilities for that position.

Firefighter

Performs intermediate protective service work in fire suppression and related tasks as required, under regular supervision. A Firefighter's typically assigned tasks are:

- Respond to alarms and assist in the suppression of fires, including rescue, entry, ventilating, salvage, and emergency medical response tasks
- Performs overhaul and incident cleanup assignments
- Assists in cleaning, inspection and maintaining fire apparatus, tools, hoses, and equipment
- Cleans apparatus, fire station and conducts grounds maintenance tasks
- Participates in training evolutions, attends scheduled drills and classes
- Shuts off gas and electrical utility service to building
- Serve as a relief driver if qualified
- Identifies principal types of building construction and the fire behaviors expected of each type of building construction
 Policy I
- Prepares and submits required incident and maintenance reports
- Assist with Public Relations and Public Education events, such as station tours, demonstrations, and other programs
- Assist in conducting pre-incident planning surveys
- Perform special area or project assignment tasks as assigned
- Perform other firefighting and related emergency tasks consistent with appropriate NFPA standard for duty position
- Conduct other assigned duties as required

Firefighter Knowledge, Skills and Abilities

The following knowledge, skills and abilities are required of all Firefighters:

- General knowledge of firefighting and fire suppression techniques and procedures
- General knowledge of pre-incident planning and fire prevention and education
- General knowledge of emergency medical techniques and procedures
- General knowledge of technical firefighting and the principles of hydraulics as applied to fire suppression
- General knowledge of the Fayetteville and Cumberland County layouts and Stoney Point Fire District streets
- General knowledge of hazardous materials operations level assignments
- General knowledge of vehicle and machinery extrication principles and techniques
- General knowledge of the Incident Command System
- Ability to understand and follow oral and written instructions
- Ability to establish effective working relationships with other members and the public
- Possession of physical endurance, agility, and basic mechanical aptitude

Firefighter Education and Experience

The minimum standard of Firefighter education and experience for operation as a member of Stoney Point Fire Department is successful completion of the department's Recruit Training Program. However, the following education and certification is highly encouraged for volunteer members and the minimum requirement for career members:

- High School Diploma, or General Education Diploma
- North Carolina IFSAC certified Firefighter
- Valid North Carolina driver's license (preferred)
- North Carolina certified Emergency Medical Technician (preferred)
- North Carolina IFSAC certified HAZMAT Operations level responder (preferred)
- North Carolina IFSAC certified Technical Rescuer (preferred)

Fire Apparatus Driver/Operator (Engineer)

Performs difficult protective service work in driving fire apparatus and in the operation of pumps and fire suppression equipment. Performs immediate protective service work in fire suppression does related work as required under regular supervision. Supervises assigned members in the absence of a Fire Officer. Typical tasks performed by a Driver/Operator are:

- Respond to alarms, drive assigned apparatus to required location
- Operate pumps and apparatus at incident scene; regulates water pressure to ensure required pressure at the nozzle
- Assists in fire suppression including rescue, entry, ventilation, salvage, and emergency medical response tasks
- Assume primary responsibility for servicing and maintaining fire equipment
- Assist in the cleaning, inspection, and maintenance of fire apparatus, equipment, hoses, tools, the fire station and grounds
- Instruct other members in the operation and care of fire equipment
- Participate in and lead training evolutions, attends scheduled drills and classes
- Supervise Firefighters in the absence of a Company Officer
- Identifies principal types of building construction and the fire behaviors expected of each type of building construction
- Prepares and submits required incident and maintenance reports
- Assist with Public Relations and Public Education events, such as station tours, demonstrations, and other programs
- Perform special area or project assignment tasks as assigned
- Perform other firefighting and related emergency tasks consistent with appropriate NFPA standard for duty position
- Conduct other assigned duties as required

Driver/Operator and Engineer Knowledge, Skills and Abilities

Fire Lieutenant

Performs difficult protective service directing and supervises a Fire Company or performs specialized work within the department; performs related tasks as required. Exercises supervision over assigned shift personnel. Performs Incident Command duties and the following typical tasks:

- Respond to fire alarms, directs the work of fire suppression personnel
- Instruct subordinate fire personnel in duty assignment and procedures
- Supervise and participate in the task of extinguishing fires and the performance of related life and property protection
- Supervise and participate in the task of incident stabilization, technical rescue, hazardous materials, and emergency medical response
- Direct the training activities of assigned personnel in all phases of firefighting, rescue, medical, and hazardous materials response
- Operate pumps and apparatus at incident scene; regulates water pressure to ensure required pressure at the nozzle as needed
- Performs Incident Command or other supervisory role at the incident scene as assigned
- Supervise the daily operations within a fire station; ensures task completion and that an adequate inventory of necessary equipment is available
- Supervise and conduct hydrant testing, hose testing, apparatus, and pump testing
- Identifies principal types of building construction and the fire behaviors expected of each type of building construction
- Prepares and submits required incident and maintenance reports
- Initiates pre-incident planning programs
- Supervise the maintenance and testing of apparatus and equipment
- Develops and instruct training programs, supervises drills, and requests training classes
- Maintain records and complete operational and personnel reports; evaluate performance of subordinates
- Assist with Public Relations and Public Education events, such as station tours, demonstrations, and other programs
- Perform special area or project assignment tasks as assigned
- Perform other firefighting and related emergency tasks consistent with appropriate NFPA standard for duty position
- Performs related tasks as required

Fire Captain

Performs difficult protective service directing and supervises a Fire Company or performs specialized work within the department; performs related tasks as required. Exercises supervision over assigned shift personnel. Performs Incident Command duties and the following typical tasks:

Training Officer

Performs difficult protective services and responsible administrative work in the development and administration of training programs with the department; performs related tasks as required. Work is performed under regular supervision. Supervision is exercised over subordinate protective service personnel during instruction. Performs Incident Command duties and the following typical tasks:

- Develop the training policies, goals, and objectives of the department
- Identify training needs, prepare, and evaluate training programs
- Develop schedules and supervise recruit and in-service training
- Respond to large incidents to observe safety and operational practices for use in assessing training needs
- Observe instructional techniques of Company Officers
- Suggest alternative training methods or approaches as appropriate
- Select, requisition, and distribute instructional materials
- Maintain training records and prepare monthly reports
- Participate in evaluation of candidates for promotion
- Acquire and maintain the latest materials and resources concerning training and extinguishing methods to be available to all Fire Department personnel
- Performs related tasks as required
