# B: ANNUAL / SPECIAL / PUBLIC HEARING MEETING:

C: READING AND APPROVAL OF THE MINUTES OF THE LAST MEETING:

 Secretary Roger Hall presented the minutes from the September 19, 2023, Monthly Board of Directors' meeting for review and approval. Chairman Brown called for the approval of the September 19, Monthly Board of Directors' Minutes. Vice Chairman Larry Townsend made a <u>MOTION</u> to approve the September 19, 2023, Monthly, Board of Directors' minutes as presented. The motion was <u>SECONDED</u> by Treasurer Gary Turlington and unanimously <u>APPROVED</u>.



# D: REPORT OF THE FIRE CHIEF:

- 1. <u>General Information</u>. Chief Johnson Sr. welcomed the members of the board to the October meeting. He reminded the members that Director Bo Barbour is out on an extended medical leave of absence until the first of the year.
- 2. <u>Guests:</u> None
- 3. <u>Personnel:</u>
- 1. Chief Johnson provided an update on our on-going volunteer recruiting efforts since the first of the year. So far this year through October 17 we had 47 volunteer applications submitted for membership. Six (6) did not move forward due to back-ground issues, while eleven (11) did not complete our recruit training program for various issues. Claustrophobia issues ranked on top of the list, while others realized they did not have the time to commit to volunteering. Thirty (3) of those are now in varying stages of completing our recruit training program. We are starting our final recruit class for 2023 next month in November and this class will run into 2024. The chief also stated that we had five (5) new applicants walk in last Thursday night, with their applications being processed. He reminded the members of the board that our recruiting efforts are on-going throughout the year. He also highlighted that some of our volunteer turn-over is contributed to our active-duty military members who are scheduled to exit the military or being reassigned by the military to other bases.
- 2. Chief Johnson also addressed our full and part-time staffing posture and announced that we currently have two (2) full-time position vacancies. One (1) member resigned to accept a higher paying job, while the other was terminated. We have been utilizing part-time members to fill the void. We do have several internal and external candidates that have expressed interest in the positions, and the Chief will fill both positions early next year. The chief also stressed that by using part-time members we save on our salary and benefit budgets.

# E: Apparatus Fleets:

- The Chief advised that Truck 1351, our Ladder Truck, is still at Gregory Poole awaiting parts. We did find the required motor-mounts, but they are still three (3) months out from shipping. We have received the six (6) required rubber bushings that go with the six (6) motor mounts. The Chief expressed that due to the parts supply issues our ladder truck will not be back in service before the first of the year.
- 2. The Chief advised that the Motorola in-car camera system is providing us with great feedback in terms of safe driving, interior observations as well as on-scene exterior observation if in camera view. Unless there is a complaint, we have it set up to randomly review incident runs every Friday. All our officers have access to the system and can review at any time. They do not have any editing or deleting permissions. Only the primary administrators have access to edit or delete. We will establish a Standard Operating Guideline (SOG) for the use, reviews as well as system editing or deleting. Vice-Chairman Townsend has access to the system, with Assistant Chief Hanzal and the Fire Chief having full system permissions. Chief Hanzal is not authorized to edit or delete video footage. We have it set up where the footage is over-written after 90 days. So, in other words stored videos will eventually time out.



3. The Chief advised that we are waiting on graphics for 1341 from Image Graphics and hope to have the truck back at Station 13 by the end of the month. The old 1341 has been parked out back next to the Conex boxes at Station 19 and will be used for parts.

## F: <u>Building and Grounds:</u>

- 1. The Chief advised that although the PWC sewer lines have been installed on our property, it will be May or June of 2024 before connections with PWC will be possible.
- 2. We have transformed our back field at Station 13 to accommodate our annual Trail of Terror fund raiser.
- 3. We experienced septic tank issues during our opening Trail of Terror weekend at Station 13. Our septic tank required to be pumped out. Our installed pump that pumps liquids to the septic tank in our back yard suddenly stopped working. Carter's Septic Tank Services determined that



our pump was still good, however the 220-Watt electrical outlet stopped working. We have a new outlet on back order because we could not locate one here in Fayetteville.

4. The Air Conditioning Unit that cools and heats the Station 13 Computer Room is eight (8) years

old. The unit stopped cooling and required a new mother board. Because the unit is over five (5) years old parts are now harder to find. The technician also informed Chief Johnson that we will also start to have other issues arise with the unit that will start costing money. As a result, the decision was made to replace the unit with a new unit. This will run about \$6,500.00 installed. Nathan's Heating and Air Conditioning was hired.

# H: <u>Training Report:</u>

- The new Fayetteville Technical Community College (FTCC) Swift Water Center's ribbon cutting is scheduled for Monday November 13, 2023, at 2 PM at the new Regional Dr. Larry J. Keen Fire and Rescue Training Center. FTCC staff is already working on scheduling classes. Our Assistant Chief Sean Johnson will be one of the Swift Water Certification Instructors. (See Enclosure #3)
- 2. With the 2024 North Carolina Association of Fire Chiefs (NCAFC) Mid-Winter Conference (MWC) scheduled for Tuesday January 30, through Saturday February 3, 2023, our entire Chief Officers corps has been scheduled to attend the training conference. One of our senior Captains will be in charge with our on-call chief officer being about 2 hours away and ready to return should there be a need.



- 3. Chief Johnson also informed the members of the board that the 2024 Fire Department Instructor Conference (FDIC) is scheduled from April 15 - 20, 2023 in Indianapolis and along with the Chief the following department officers have been registered. Captains Jose Pomales and Arthur Swartz, Lieutenants Wendell Cammuse and Spencer Goodwin. Assistant Chief S. Johnson is also attending with no costs to the department. FDIC is another annual training event that we attend to stay abreast of nationwide initiatives.
- 4. Chief Johnson Sr. informed the members of the board that after meeting all the recertification training requirements, that his North Carolina Executive Emergency Management Certification was renewed for the next five (5) years by the North Carolina Emergency Management Training Division. Recertified in EM for the next five years. (See Enclosure #4)
- 5. The Chief advised that we have a Live Training Burn Scheduled at the Regional Training Center on Saturday November 4, 20023 from 9 until 5 PM. All our volunteers and our new recruits meeting the NFPA 1043 Live Burn standard will participate. Our full and part-time staff will do the same training in-conjunction with the Fayetteville Fire Department Live Fire Training schedule in November also.
- 6. Training other than on-line and selected special technical training during the month of October has been suspended. This is something we do each year during the "Trail of Terror" fund raiser which requires extensive assistance from our volunteer membership.
- 7. Currently we have several of our paid staff members attending the Technical Rescue (TR) certification at Robeson Community College. With I-295 scheduled to partially open from Camden Road to I-95 south we will move our Rescue Truck to Station 19. The I-295 on and off ramp on Glenn Road is only about 6 tenths of a mile from Station 19. That will allow Rescue 13 to respond both North and South. We will enter into an agreement with the City of Fayetteville to assist us by coming North and us going South and we will do the same agreement with both Parkton and St. Paul's Fire Departments in Robeson County. TR is a required skill for all our officer's corps and full-time members and optimal for our volunteers.
- 8. The Chief also advised that we currently have both volunteers and full-time members attending the North Carolina Emergency Medical Technician-Basic (EMT-B) course. We have members enrolled in both day and night courses. With over 50% of our total calls being medically related EMT-B is a job requirement for our full time and career members.
- 9. Chief Johnson also informed the members that he is currently attending the North and South Carolina Association of International Association of Arson Investigator joint chapter annual training conference. The weeklong training conference is held in Myrtle Beach, South Carolina and the annual training classes meet the North Carolina Certified Fire Investigator Boards (CFIB) recertification requirements for Certified Fire Investigators (CFI). Having CFIs in our agency also provides us with extra credit during our Insurance Service Office (ISO) rating requirements.

1.. Treasurer Gary Turlington reminded the members that both June and July 2023 financials remain with our accountant reference our FY-22-23 annual audit and will not be available for review



until the completion of our audit. He presented the August 2023 financials review along with the oversight review memorandum conducted by Vice Chairman Townsend indicating that no discrepancies were noted. He further stated that September and October 2023 financials will be presented to the board during our November 21, 2023, meeting. After a review by the attending members Chairman Brown called for a *MOTION* to approve or disapprove both the financial and oversight report for August 2023. Secretary Roger Hall introduced a *MOTION* to APPROVE both the Financial and financial oversight report for the month of August 2023 as presented. The MOTION was *SECONDED* by Vice Chairman Townsend and *APPROVED* by all members present. (See Enclosure #5)

- 2. <u>Auxiliary Account</u> Treasurer Tracie Johnson, via text message provided the Auxiliary Account fund balance of <u>\$530,770.94</u> as of October 17, 2023.
- 3. <u>Miscellaneous Firefighter Account</u> (Ice & Cans) Our balance as of October 17, 2023, is <u>\$15,629.03</u> We have our final summer sales deposit pending.
- 4. <u>Firefighter Relief Fund</u> Vice-Chairman Townsend who also serves as treasurer of the firefighters relief fund board advised that a <u>\$13,234.40</u> deposit was made into our relief fund checking account, representing this years disbursement. With the new deposit our current relief fund checkbook balance is <u>\$33,379.39</u> and our current relief fund CD is holding steady at <u>\$78,600.23</u>. He also advised that he would transfer <u>\$13,000.00</u> from the checkbook account to the Certificate of Deposit Account and report the new balance during our November 2023 board meeting.(See Enclosure #6)
- 5. <u>Child Passenger Safety Seat Account</u> The Chief advised that the fund balance with TRUIST as of September 19, 2023, is \$<u>1,225.51</u>
- <u>Station 19 Building Loan -</u> Vice Chairman Townsend updated the members of the board and stated that the current balance on our Station 19 building loan with First Citizens Bank as of September 19, 2023, is <u>\$480,885.11</u> with sixty-three (63) monthly payments consisting of <u>\$7,562.05</u> remaining.
- 7. <u>Pierce Fire Truck Loan– (\$1,400,000.00 First Citizens Bank)</u> Chief Johnson Sr. reported that as of October 17, 2023, 2023, the outstanding commercial loan balance is <u>\$631,974.07</u> He reminded the members of the board that our truck payment plan is annual therefore there is no change to loan balance until the next annual payment is applied.

# J: **REPORT OF COMMITTEES:**

- 1. <u>Policy Committee</u> Meets Annually during the first quarter of the year. Per PEER team recommendation the policy committee's annual review has been moved to the first quarter of each new calendar year.
- 2. <u>Building & Grounds Committee</u> See Item F (On-going monthly during our BOD Monthly meetings).
- 3. <u>Small Tools & Gear Committee</u> Meets semi-annually Mar/Apr & Oct/Nov The next meeting is tentatively scheduled for the 3<sup>rd</sup> week in October 2023.
- 4. Equipment & Vehicle Replacement Committee 2023 Minutes are on file.





- <u>Budget Committee</u> (Meets Annually) The budget committee met on Saturday March 18, 2023, to produce recommendations for the FY23-24 budget addressed during the public hearing portion of these minutes. (See the Budget Committee Minutes dated March 18, 2023)
- 6. <u>Safety and Health Committee</u> Quarterly meeting minutes are on file.

# K: OLD BUSINESS:

- 1. With only 7 weeks before our annual 2023 Annual Family Christmas Dinner, Chief Johnson provided another reminder for the board members to place this important date on your family calendar.
- 2. The Chief stated that our twenty (20) sets of Personal Protective Ensemble (PPE) have been delivered and issued out to our members. We are now in the process of recouping our funds. This PPE purchase was part of the FY 22-23 the Cumberland County Fire Protection District Grant Program. We will also apply for the FY 21-22 PPE order refund, which is now complete as well.
- 3. There have been no further updates concerning our ordered FIROVAC Tanker with a 2025 Freightliner Chassis and a 3500 Gallon water Tank. The president of the company stated that he has hired additional staffing and hopes to deliver our tanker late next year. We are still planning on touring the factory after the arrival of our chassis next year.
- There has been no further action taken on the replacement of our letter sign marquee at Station 19. Current inflation prices associated with electronic marquees are so high, that the Chief recommended to take a wait and see attitude.
- 5. The Chief stated that METRONET came out today to do a site survey to see what is needed to switch us from Spectrum to METRONET for a much faster speed as reported during our September 2023 meeting. He hopes to be totally switched over by our November meeting.
- 6. The Chief announced that the annual Fire, Rescue and EMS worker memorial service was conducted last Saturday at the new Regional Fire and Rescue Training Center with about 60 in attendance. The service was moved into the main classroom due to inclement weather. There were two (2) Line of Duty names added to the memorial this year. It was a great service and well attended. (See Enclosure #7)

# L: NEW BUSINESS:

- 1. The Chief announced that it is time to prepare for our annual family awards Christmas banquet and a memorandum is forth coming to announce our 2023 awards selection board. Two (2) members from the board have traditionally assisted with that endeavor. Both Treasurer Turlington and Assistant Treasurer Jerry Hall and Vice Chairman Townsend have served on the committee in previous years.
- 2. The Cumberland County Fire Chiefs' Association (CCFCA) has also opened nominations for the annual Arnold J. Koonce Legacy Leadership Award. Nominations are open through November 30, 2023. Nominations can be submitted on-line @ CCFCANC.com.
- 3. The North Carolina Association of Fire Chiefs (NCAFC) annual Fire Chief and Fire Officer of the Year nominations are being accepted through October 31, 2023. Nominations can be submitted through the association's website.



- 4. The Chief provided an update on our annual fund raiser the "Trail of Terror" and reported that after two six (6) hour weekends have grossed \$79,188.00. He also announced that our on-line sales have been tremendous. We have two (2) weekends and Halloween night left. The last two (2) weekends are generally our biggest weekends. Saturday nights are always our biggest customer participation nights, while Friday nights we are in competition with high school sports activities and other events offered in Fayetteville. So far, we have been receiving great reviews on our Facebook page.
- 5. The Chief informed the members that we now have completed installation of cameras and equipment to support zoom meetings in both Station 13 and 19.
- 6. The Chief announced that he has a meeting scheduled with County Manager Clarence Grier and Emergency Services Director Gene Booth, to discuss our expiring county fire protection contract, up-coming FY 24/25 re-evaluation funding and communications issues.
- 7. Member Jimmy Mabe completed his NC EMT Certification. Jimmy has been trying for years to obtain that certification. He never gave up.
- 8. The Chief advised that he attended the Quarterly North Carolina Fire and Rescue Commission Meeting in Weaverville (Asheville) North Carolina last Tuesday October 10, 2023, and provided a quick overview.
- 9. The Chief advised that during the September Fire Chiefs Meeting in Godwin-Falcon former North Carolina State Senator Kirk deViere was presented with his Honorary Fire Chiefs' Helmet. Senator deViere was initially inducted as an honorary Fire Chief with the Association during our 2022 Christmas Meeting along with Dr. Larry Keen, President, Fayetteville Technical Community College (FTCC) for his contributions and work for the Association while serving as our Senator in the General Assembly. Because of supply issues the special presentation helmet was on back-order and just recently received.
- The Chief passed around a letter from Lumbee River Electric Membership Corporation (LREMC) announcing capital credits check to our organization. Station 19 is serviced by LREMC. (See Enclosure #8)

# **RE: Misinformation Concerning General Assembly Budget Negotiations**

During the past two weeks some incorrect information was provided by another fire service group concerning the actions of the NC State Firefighters' Association (NCSFA) regarding budget negotiations within the NC General Assembly. The information provided on social media and in newsletters indicated the NCSFA had opposed permanent funding of firefighter cancer insurance. It also indicated that this other group had saved the day by protecting the funding. These were baseless claims and lies. Just as passage of firefighter cancer was a top priority in 2021 for NCSFA, so was continual funding a priority in this year's General Assembly session.

While the NC State Firefighters' Association works tirelessly for every firefighter in North Carolina, it is the firefighters, both career and volunteer, that hold the success of the passage of firefighter friendly legislation, by speaking with and contacting their representatives.

Two years ago, the NC State Firefighters' Association, working with the NC Association of Fire Chiefs, began collecting and analyzing data from the Department of Insurance concerning the Gross Premium Assessment (often called the Gross Premium Tax) and formulating a plan to permanently fund Firefighter Cancer Insurance from portions of proceeds previously going to the Volunteer Workers Comp Fund (VSWCF). Last Fall, the joint legislative Committee of NCSFA/NCAFC reviewed language to accomplish that, which was later provided to Senator Todd Johnson representing Cabarrus and Union Counties, and became SB 326, which passed the Senate this year with bipartisan support. That bill would have permanently funded Firefighter Cancer Insurance into the future, as well as fixed some issues with the Volunteer Safety Workers Comp Program (VSWCF).

This plan of action is well documented in legislative messaging from our organization. TO BE CLEAR, NCSFA DID NOT OPPOSE CANCER FUNDING IN ANY MANNER, AND THE GROUP PRESENTING THIS MISINFORMATION HAD NOTHING TO DO WITH THE RESEARCH, DEVELOPMENT, AND ACTIONS TRYING TO SECURE PERMANENT FUNDING THROUGH SB 326.

The concerns the NCSFA had with the budget, as presented, were as follows:

- It did not include the language from SB 326 which would have permanently funded cancer and kept workers comp (VSWCF) reserves funded at an adequate level.

- It indicated the cancer pilot program worked, but then gave the Department of Insurance responsibility for managing it, who does not have the staff, and loses the quality management it had during the pilot program with over 115 claims.
- It continued to reduce the reserve funding for VSWCF and took responsibility away from the Fire and Rescue Commission, whose VSWCF Board had successfully managed the program for over a decade. It also limited the ability for local agents to work with departments, bringing into question how local departments would acquire this coverage.
- It removed the Commissioner of Insurance as State Fire Marshal, bringing confusion into the operation of fire service programs, and ended a system that has worked since the mid 1900's.

The history and actions of the NC State Firefighters' Association on these issues and working with the Chief's Association are well documented. Just follow the facts.

The NCSFA continues to work toward a budget correction on these issues, whether now or in the short session of the General Assembly next year, and will seek passage of legislation that permanently funds Cancer Insurance for Firefighters and maintains a viable self-funded workers compensation program for volunteers.
